## HIV-1/M+O INTERGROUP DUAL INFECTIONS AND ASSOCIATED HIV-MO RECOMBINANTS IN FRANCE FROM 2004 TO 2014

### BACKGROUND

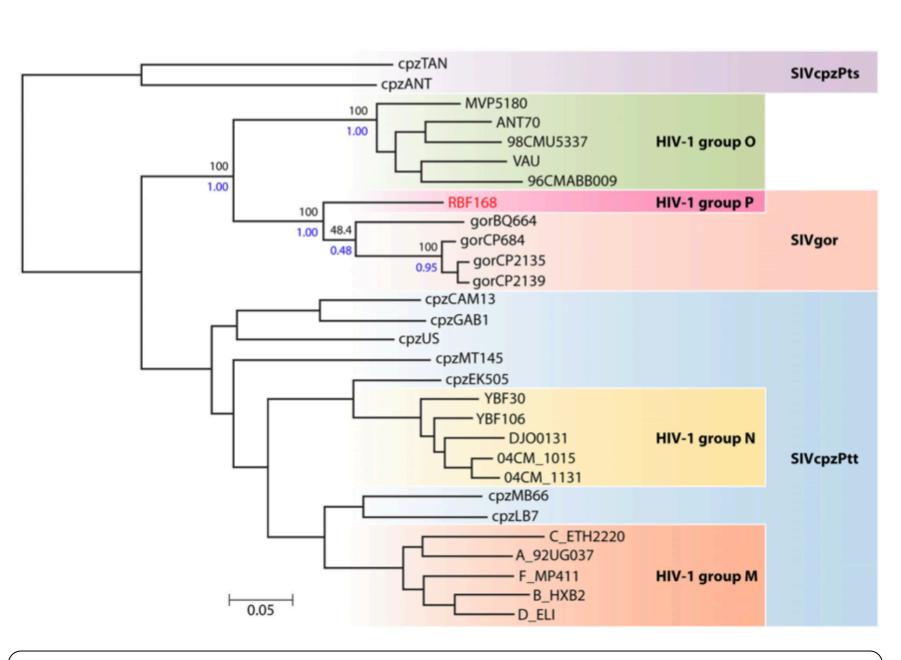
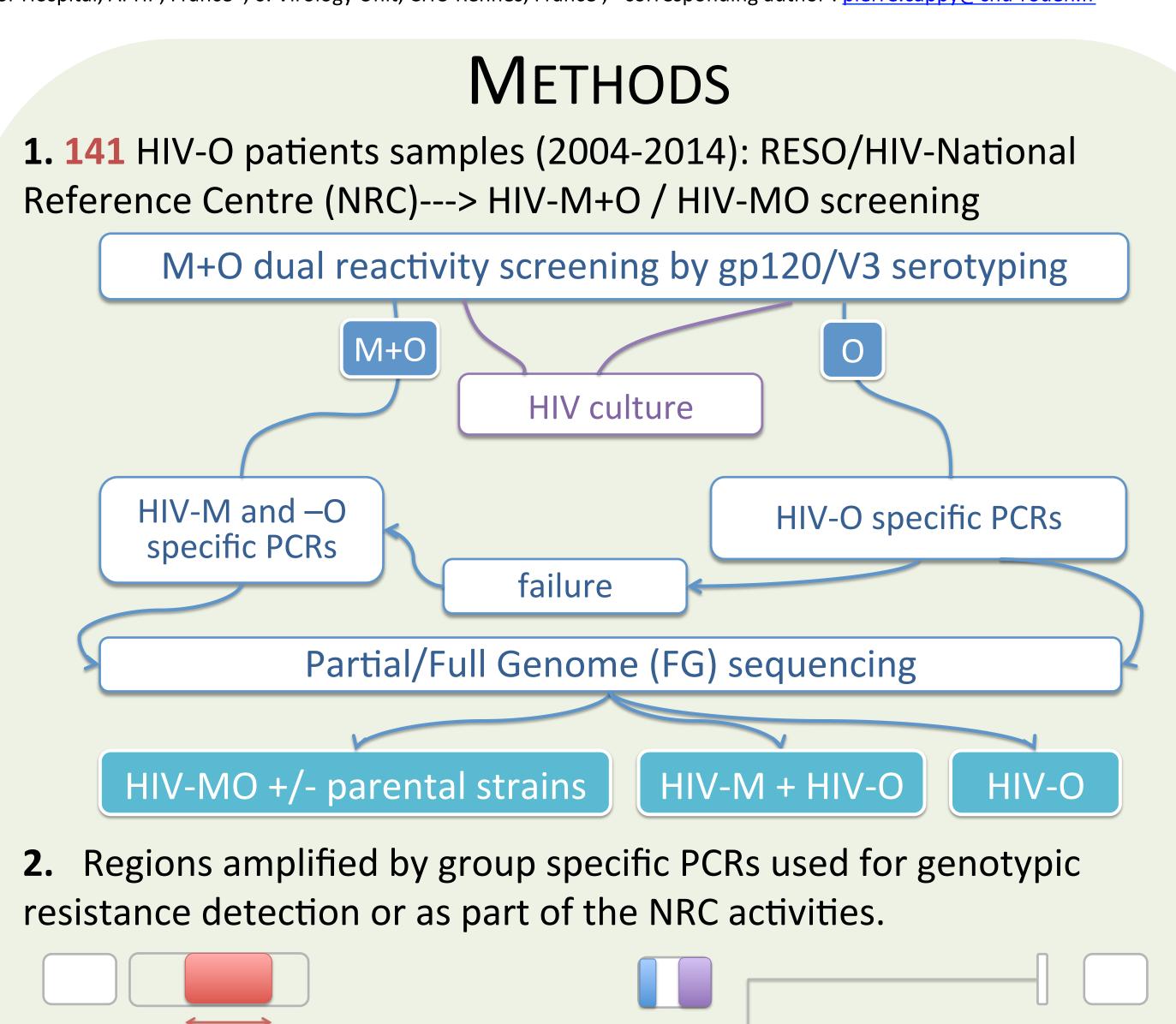


Figure 1. Genomic diversity of HIV-1<sup>1</sup>

HIV-1 exhibit a high genetic diversity. It is currently divided into 4 groups: M, N, O and P as shown on figure 1<sup>[1]</sup>. Recombination is a crucial mechanism of HIV evolution, and HIV-M recombinants now account for more than 20% of HIV-1 infections<sup>[2]</sup>. HIV-M and HIV-O co-circulation in Cameroon led in few patients to dual infections and to the subsequent generation of MO recombinants (MOrecs). The first dual M+O infections were described in Benin in 1995<sup>[3]</sup> and 3 MOrecs In this study, we aimed to were identified in Cameroon in 1999<sup>[4,5]</sup> and detect these forms among 2004<sup>[6]</sup>. Due to historical links with Western patients diagnosed in France Central Africa, dual infections<sup>[7,8]</sup> and MO with an HIV-O infection, and recombinant infections<sup>[9]</sup> have also been characterising the MOrecs described in France.

## RESULTS

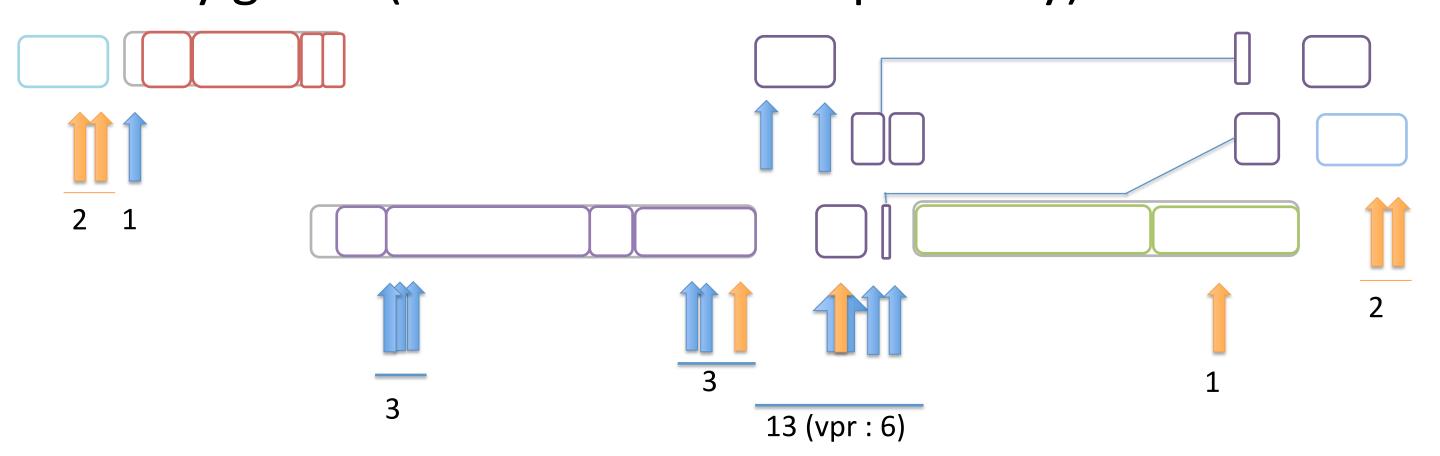
The presence of both M and O genomes were detected in 10/141 samples (7%) from HIV-O infected patients.

The analysis of these cases allowed us to identify different situations:

- 2 M+O dual infections in 2 patients (in 2004 and 2009),
- 3 MO recombinants associated:
  - with the HIV-O parental strain in 2 epidemiologically linked patients (BCF174, 2005 and **BCF212**, 2006)
  - with both the M and O parental strains in 1 patient (BCF204, 2013)
- 6 MO recombinants without parental strains:

-RBF208 (2008), RBF222, (2010), RBF234 (2013), RBF221 (2 recombinants in the same patient, 2010), RBF235 (2013).

For each of these MO recombinants, whole genome or partial sequences were analysed. All the MO recombinant genetic patterns were different with breakpoints in LTR (1/8), p17<sup>GAG</sup> (1/8), RT (3/8), INT (2/8), gp41 (1/8) and/or accessory genes (6/8) as shown in the figure 2 and 3. The 2 viruses found in the same patient RBF221 exhibited multiple breakpoints in the accessory genes (at least 2 and 5 respectively).

## Conclusion

Although all described in Cameroonian native patients, we showed HIV-M+O dual infections and MOrecs circulate in France. Moreover, the presence of MO recombinants circulating alone and in epidemiologically linked patients demonstrate they are fit enough to be transmitted and spread. Finally, as HIV-O are naturally resistant to NNRTIs, the transmission of HIV-M+O dual infections or MOrecs carrying HIV-O genomic fragments underline the importance of searching for these forms, evaluate their spread dynamics and follow the possible emergence of a CRF MO.
