Radical Amido- and Azido-Fluorination of α-Fluorostyrene Derivatives: An Innovative Approach Towards β-Aryl-β,β-difluoroamino Motifs

An innovative one-step synthesis towards *β*-aryl-*β*,*β*-difluorocarbamates and *β*-aryl-*β*,*β*-difluoroazides is presented. The described approach relies on the use of *α*-fluorostyrene substrates in a radical addition/fluorination reaction with N-centered radicals in the presence of Selectfluor®. The best results were

Introduction

The *gem*-difluoromethylene $(-CF₂-)$ unit is a versatile fluorine substitution widely employed in medicinal chemistry to modulate the properties of drug candidates (*e.g.* conformation, lipophilicity, pKa of proximal chemical functions).[1] Such a fluorinated motif has also been exploited in structure-activity relationship (SAR) studies as a bioisostere of carbonyl or ether groups,^[2] and to improve the metabolic stability when located at a benzylic position.[3] For instance, the *β*-aryl-*β*,*β*-difluoroamines are useful fluorinated building blocks in order to introduce a *β*-aryl-*β*,*β*-difluoroamino motif into drug candidates. As a result, this motif can be found in several biologically active molecules (Figure 1).^[4]

The synthesis of such a motif remains rather challenging and only few methods have been reported in the literature. For instance, the fluorination of 2*H*-azirines in the presence of Olah's reagent provides a direct access to *β*-aryl-*β*,*β*-difluoroamine albeit a narrow substrate scope (Scheme 1a).^[5] The use of benzene as solvent was found crucial to limit the formation the side-products pyrazine and *α*-fluoroketone, especially when substituted 2H-azirines ($R = alkyl$) were employed in the transformation. Another straightforward strategy relies on the reduction of either *α*-aryl-*α*,*α*-difluoro-amides or -nitriles into the corresponding amines in the presence of borane (Scheme 1b).[6] However, the reductive conditions may limit the functional group tolerance of this approach. Recently, tosyl-

obtained for the azidofluorination reaction. The resultant *β*-aryl*β*,*β*-difluoroazides were further transformed into Nitrogenbased heterocycles (*e.g.* pyrrole, triazole, and tetrazole) and in more elaborated azide derivatives.

protected *β*-aryl-*β*,*β*-difluoroamines have been synthetized by the addition of *α*-aryl-*α*,*α*-difluorohexamethylborazine adduct to tosyl-protected aryl imines (Scheme 1c).^[7] Although this method represents a useful route towards substituted *β*-aryl $β_iβ$ -difluoroamines, it requires the prior preparation of the ArCF₂ reagents and final removal of the tosyl group in order to access the free amine. Alternatively, the reduction of *β*-aryl-*β*,*β*difluoroazides under standard hydrogenolysis or Staudinger conditions represents an attractive strategy towards *β*-aryl-*β*,*β*difluoroamines (Scheme 1d). Indeed, besides being amine precursors, azides are used in a wide range of transformations towards nitrogen-containing molecules,^[8] in bioorthogonal ligation reactions and are also found in biologically active molecules.[9,10] Traditionally, the synthesis of *β*-aryl-*β*,*β*-difluoroazides is accomplished by S_N^2 type reactions between sodium azide and a difluorinated precursor containing a leaving group (Scheme 1e).[11] More recently, *β*-aryl-*β*,*β*-difluoroazides have also been prepared from *α*-azidostyrene derivatives via a 1,2 azide migration/difluorination reaction sequence (Scheme 1f).^[12] The latter is promoted by hypervalent iodine reagents in the presence pyridine.HF complex. Although this method proved to be efficient with electron-poor *α*-azidostyrenes, the use of electron-rich substrates led predominantly to *β*-aryl-*α*,*α*-difluoroazides via a 1,2-aryl migration/difluorination reaction sequence instead. Given the importance of the *β*-aryl-*β*,*β*-difluoroamino motif in medicinal chemistry, the development of new approaches towards *β*-aryl-*β*,*β*-difluoroamine/azide compounds remains desirable. Radical fluorination (RF) reactions, which have become over the years a valuable synthetic tool to access mono-fluoro alkyl derivatives **A**, [13] have also been found, to a lesser extent, suitable for the synthesis of CF₂-containing molecules **B** (Scheme 2a).^[14] In this case, the construction of the CF₂ unit relies on two successive RF reactions; each of them involving the same Single-Electron Transfer (SET)/Fluorine Atom Transfer (FAT) sequence. More specifically, such an approach has been used to access the Ar-CF₂ motif as illustrated by the double RF of benzylic $C(sp3)$ -H (Scheme 2b),^[14a,c,d] and $C(sp3)$ -CO₂H (Scheme 2c) bonds.[14f] Thus, the initial SET event (respectively, Hydrogen Atom transfer (HAT) and SET^[OX]) of each RF reactions, generates the alkyl radical **C** and the mono-fluoro alkyl radical **D**. In the presence of Selectfluor® reagents as a radicophilic fluorine source (Scheme 2d), each of these radicals, respectively participates in a FAT step to form both of the $C(sp3)$ –F bonds. Although these double RF reactions have their own limitations (*e.g.* selectivity, availability of starting material, efficiency, *etc.*), overall, they demonstrate that the mono-fluoro alkyl radical **D** is a promising intermediate towards CF_2 -containing molecules. In this context, we were wondering: a) Could a new RF transformation towards CF₂-molecules, relying on intermediate **D**, be alternatively developed to the double RF strategy? b) Could such a method be exploited to access *β*-aryl-*β*,*β*-difluoroamines and/or *β*-aryl-*β*,*β*-difluoroazides aforementioned?

Among the RF reactions allowing the synthesis of monofluoro alkyl derivatives **A**, the radical addition/fluorination reactions of olefins are of particular interest (Scheme 2e). Indeed, the addition of a radical Y^{*} (*e.g.* $Y=H_r^{[15]}$ I,^[16] P-,^[17] N-,^[18]

 $O₇$ ^[19] or C-centered radicals)^[20] to an alkene substrate and subsequent FAT between the radical adduct **C** and a fluorine source allows the formation of two bonds in one step, respectively $C(sp3)$ –Y and $C(sp3)$ –F. Alternatively, rare examples of radical hydrofunctionalization reactions of non-activated *α*fluoroolefins ($R \neq EWG$) have also been reported for the synthesis of mono-fluoro alkyl derivatives **A** (Scheme 2f).[21] In this particular case, the mono-fluoro alkyl radical **D** is generated upon the radical addition of Y* , and a subsequent HAT step gives **A**. By merging the concepts of the aforementioned studies, it occurred to us that the use of α -fluoroolefins^[22] in a radical addition/fluorination transformation could potentially deliver the targeted CF₂-containing molecule **B** (Scheme 2g). More specifically, the development of a radical addition/ fluorination of α -fluorostyrenes (R=Ar) with N-centered radicals would provide a readily access to the *β*-aryl*-β*,*β*-difluoroamino motif. Herein, we report our finding regarding the proposed work hypothesis.

Results and Discussion

To initiate our study, *α*-fluorostyrene **1a** was chosen as a model substrate and was first submitted to the conditions of radical amidofluorination of alkenes previously reported by Studer's group (Scheme 3a).[18d] Both amidyl radical precursors **2a** and **2b** were tested in the presence of the organic photocatalyst

Mes-Acr-Me and Selectfluor®. In each case, full conversion was reached after 16 h of reaction. ¹⁹F NMR analysis of the crude reaction mixtures indicated the formation of the desired products **3a** and **3b** in low yields (25% and 27% NMR yields, respectively) alongside traces of several uncharacterized fluorinated side-products. Although the protected *β*-aryl-*β*,*β*-difluorocarbamates **3a** and **3b** were respectively isolated only in 22% and 21% yields, these results validated our work hypothesis. Next, we turned our attention to the radical azidofluorination protocol reported by Li's group (Scheme 3b).[18b] In this case, *α*fluorostyrene **1a** was treated with trimethylsilyl azide (TMSN₃) in the presence of trifluoroacetic acid (TFA) and Selectfluor®. After 16 h of reaction, ¹⁹F NMR analysis of an aliquot indicated full conversion of the substrate. In this case, ¹⁹F NMR analysis of the crude reaction mixture was cleaner than those obtained previously from the amidofluorination transformations, and showed the formation of the desired *β*-aryl-*β*,*β*-difluoroazide **4a** in 60% NMR yield. The latter was further isolated in 55% yield. A brief survey of the reaction conditions indicated that both the absence of TFA and water is deleterious to the efficiency of the transformation (**4a**, 40% and 12% NMR yields, respectively).

Without further optimization, we decided to investigate the scope and limitations the radical azidofluorination reaction with various *α*-fluorostyrene derivatives **1b**–**y** (Scheme 4). First, the reaction was examined with *α*-fluorostyrenes **1b**–**d** possessing a methyl substituent at different positions of the aromatic ring. The efficiency of the reaction dropped significantly with *o*methyl and *m*-methyl substrates as illustrated by the isolation of difluoroazides **4b** and **4c** in 21% and 19% yields, respectively. However, substitution at the *para* position delivered the difluoroazide **4d** in moderate yield (50%). A similar trend was observed when the aryl group of the *α*-fluorostyrene was substituted by a bromine atom (**1e**–**g**). In this case, only

traces of the *o*-bromo-difluoroazide **4e** could be detected by 19F NMR analysis of the crude reaction mixture, while *m*-bromoand *p*-bromo-difluoroazides **4f** and **4g** were respectively isolated in 34% and 56% yields. The introduction of electrondonating methoxy groups on the aromatic ring of the *α*fluorostyrene (**1h**–**j**) was next investigated. In this case, the difluoroazides **4h**–**j** were isolated in moderate yields (36–51%). Then, the reaction was applied to a range of *para*-substituted *α*-fluorostyrenes (**1k**–**r**). Substrates possessing either a nitro or a methyl ketone group provided the corresponding difluoroazides **4k** and **4l** in low yields (6% and 10%). The presence of an electronic-withdrawing group such as an ester (**1m**) or an amide (**1n**, **1o**) delivered the corresponding difluoroazides **4m**–

o in low yields (24%, 19% and 26%, respectively). The aryl group of the *α*-fluorostyrene substrate could also be substituted by a Fluorine atom or a chloromethyl group at the *para* position. In these cases, the anticipated difluoroazides **4p** and **4q** were obtained in moderate yields (40% and 42%, respectively). In the case of **4q**, an attempt was made to perform the reaction in a mixture of $ACOH:H₂O$ (1:2) as solvent but no improvement was observed (21%, 19F NMR yield). The *α*fluorostyrene **1r**, featuring a biarylether motif and the naphthyl derived *α*-fluorostyrene **1s** were also found suitable for the transformation. In these cases, the corresponding difluoroazides **4r** and **4s** were both obtained in 44% yields. In addition, *α*fluoroolefins **1t** and **1u**, respectively derived from isoquinoline and quinoxaline, delivered the expected *β*-heteroaryl-*β*,*β*difluoroazides **4t** and **4u** albeit in low isolated yields (15% and 12%, respectively). Other *α*-fluoroolefins, derived from pyridine (**1x**) and quinoline (**1y**), were also tested. In both cases, the corresponding *β*-heteroaryl*-β*,*β*-difluoroazides could not be detected by 19 F NMR analysis of the crude reaction mixtures. Finally, aliphatic *α*-fluoroolefins **1v** and **1w** were also submitted to the reaction conditions. In both cases, full conversion was observed after a prolonged time of reaction (64 h). Only traces of *β*-alkyl*-β*,*β*-difluoroazide **4v** were observed by 19F NMR analysis of the crude reaction mixture and *β*,*β*-difluoroazide **4w** was isolated in low yield (25%).

Furthermore, the reaction was conducted on gram-scale from **1a** and the expected product **4a** was isolated in 50% yield (Scheme 5). In this case, careful purification allowed us to identify traces of *α*-azido- and *α*-fluoro-ketones **5** and **6** as sideproducts of the reaction (**4a**:**5:6**=39:3:1 ratio, determined by ¹H NMR analysis of the crude reaction mixture).

Based on these observations, additional information can be provided regarding the mechanism previously proposed by Li (Scheme 6).^[18b] Initially, the transformation would start with a SET event (stepwise electron transfer/deprotonation pathway or concerted proton-coupled electron-transfer pathway) between the generated in situ hydrozoic acid (HN₃) and Selectfluor[®] 7 to generate the N-radical dication **8**, a fluorine anion and the azidyl radical species **9**. Subsequent addition of the latter to the *α*-fluorostyrene **1a** generates the radical adduct **10**. At this stage, a fluorine atom transfer step between **10** and Selectfluor® **7** delivers the desired difluoroazide product **4a** (path a) and **8**. Although the fate of **8** remains unclear, the latter could act as a single electron oxidizing agent and react, like Selectfluor® **7**, with HN3 to generate **9** and reduced Selectfluor® **11**.

Alternatively, the radical adduct **10** could also be oxidized via a SET event by reacting with Selectfluor® **7** (or **8**) to generate **8** and a fluorine anion (or **11**) and the carbocation **12**. The latter could either undergo a nucleophilic addition of a fluorine anion to deliver the difluoroazide product **4a** (path b), or react with water to generate the *α*-azidoketone **5** after elimination of protons and a fluorine anion. To probe the radical nature of the proposed mechanism, we carried out an experiment on our model substrate **1a** in the presence of TEMPO (2.0 equiv.) as radical scavenger. In this case, neither the desired product **4a** or the TEMPO adduct derived from **10** could be detected. Instead, the *α*-azido-ketone **5** was formed as major product of the reaction (see Supporting Information). The presence of TEMPO seems to have no effects on the formation of the radical azide **9** but clearly inhibits the FAT step between Selectfluor® **7** and the radical intermediate **10**. In the same time, the presence of TEMPO appears to promote the oxidation of **10** into **12** resulting in the formation of **5**. Overall, given that fluorine anion is a weak nucleophile in aqueous media due to its large solvation free energy (439 kj/mol), $^{[23]}$ we believe that the formation of **4a** occurs predominantly via a radical process (path a). Regarding the formation the *α*-fluoro-ketone **6**, the latter can be explained by the electrophilic addition of Selectfluor® **7** to the *α*-fluorostyrene **1a**. In this case, the resultant carbocation **13** reacts with water and subsequent elimination of protons and a fluorine anion delivers **6**. [24]

Taking advantage of the azide functional group, we then undertake further synthetic transformations of the latter to access diverse *gem*-difluoro containing heterocycles (Scheme 7). For instance, the reduction of the *β*-aryl-*β*,*β*-difluoroazide **4a**

under Staudinger's conditions furnished the corresponding amine **14** (not further purified), and subsequent treatment with 2,5-dimethoxy-tetrahydrofuran provided the pyrrole **15** in 65% yield over two steps. Furthermore, **4a** was also submitted to various standard 1,3-dipolar cycloaddition protocols. Thus, the treatment of **4a** with diethyl acetylenedicarboxylate delivered the triazol **16** in 57% yield. In the case of Cu-catalyzed azidealkyne cycloaddition reaction (CuAAC) with phenylacetylene, the expected triazol **17** was isolated in 68% yield, alongside the iodotriazol **18** (14% yield). Finally, the reaction of **4a** with *p*toluenesulfonyl cyanide gave the tetrazol **19** in 88% yield.

Finally, we briefly examined S_N 2-type reactions of **4q** with various nucleophiles in order to access more elaborated *β*-aryl*β*,*β*-difluoroazides (Scheme 8). For instance, the reaction of **4q**

with phthalimide anion provided **20** in 71% yield. Simple phenolate and estrone-derived phenolate were also found to react with **4q** to deliver the anticipated products **21** and **22**, respectively isolated in 64% and 93% yield.

Conclusion

In summary, we have demonstrated that *α*-fluorostyrenes could undergo a radical azidofluorination reaction to deliver the corresponding *β*-aryl-*β*,*β*-difluoroazide derivatives. These compounds could be employed in useful post-functionalization reactions towards heterocycles either by taking advantage of the azide functional group as an amine precursor or as a 1,3 dipole. Overall, these results contribute to expand the repertoire of methods allowing access to the *β*-aryl-*β*,*β*-difluoroamino motif and also highlight the synthetic potential of *α*-fluoroolefins in radical addition/functionalization reactions towards CF_2 containing molecules. Further studies to probe this work hypothesis are currently underway and will be reported in due course.

Experimental Section

General procedure for the synthesis of β,β-difluoroazides 4

To solution of *α*-fluoroolefin **1** (1.00 equiv.) and Selectfluor® (2.0 equiv.) in $MeCN:H₂O$ (1:2, 0.11 M, previously degassed by sparging with argon for 10 min) were added successively at RT and under Argon atmosphere TFA (3.00 equiv.) and $TMSN₃$ (2.00 equiv.). The reaction vessel was sealed and stirred at 25°C for 16 h. After this time, the reaction was diluted with CH_2Cl_2 and H_2O . The layers were separated and the aqueous layer was extracted twice with CH_2Cl_2 . The combined organic extracts were washed with brine, dried over $Na₂SO₄$, filtered and concentrated under reduced pressure. The crude residue was purified by flash chromatography on silica gel to give the corresponding *β*,*β*-difluoroazides **4**.
