40 Legume cover crops under no-tillage favor organomineral association in

41 microaggregates and soil carbon accumulation

42 Abstract

43	Both no-tillage and legume cover crops have been shown to increase soil organic carbon		
44	(SOC) in subtropical soils. However, the mechanisms underpinning management		
45	system effects on SOC accumulation are still not well understood. We used a		
46	combination of aggregate size and density fractionation to elucidate these mechanisms		
47	at a 30-year old experiment on an Acrisol in southern Brazil. The effects of two tillage		
48	systems [conventional system (CT) and no-tillage (NT)] combined with three cropping		
49	systems [oat/maize (O/M), vetch/maize (V/M) and oat+vetch/maize+cowpea (OV/MC)]		
50	were evaluated in the top 20 cm soil layer. Overall, macroaggregation $(> 0.25 \text{ mm})$ was		
51	significantly influenced by tillage with NT showing values 14% greater than CT in the		
52	0-5 cm soil depth. On average, the occluded light fraction-C content in		
53	macroaggregates was more than twice as high under NT compared to CT (4.4 vs. 1.8 g		
54	kg^{-1}). This effect was more pronounced when legume cover crops were grown.		
55	However, the most significant effect of cover crops was observed in the organomineral		
56	fraction of microaggregates, especially under NT (12.1 under O/M and 19.8 g kg ^{-1}		
57	under OV/MC). Our results suggest that, although NT increased the occluded light		
58	fraction-C compared to CT, this effect was smaller than the gains that legume cover		
59	crops offered in organomineral association.

65 **1. Introduction**

Soil organic carbon is essential for more sustainable and resilient agricultural systems,
especially in tropical and subtropical soils, owing to its central role in determining soil
properties that strongly affect crop yield and the quality of the wider environment (Lal,
2009; Powlson et al., 2012).

70 Conservation management systems can make agricultural soils potential sinks of

atmospheric CO₂. An accumulation of SOC in agricultural systems of subtropical Brazil

72 can be achieved through management strategies such as reduced tillage or NT that

decrease the decomposition rate of soil organic matter (Bayer et al., 2006), and high C-

⁷⁴ input intensive cropping systems (Dieckow et al., 2005; Zanatta et al., 2007). Switching

75 from CT to NT in Brazilian subtropical regions can result in C sequestration rates

ranging from 0.11 to 0.68 Mg ha⁻¹ yr⁻¹ depending on the intensity of cropping systems

adopted (Bayer et al., 2006). Intensifying cropping systems in Southern Brazil usually

78 involves the insertion of cover-crop species, especially legumes, for which a positive

reffect on C input is usually related to soil N supply (Amado et al., 2006; Diekow et al.,

80 <mark>2005b).</mark>

81 Physical fractionation (density or size) has been used to study the effect of

- management systems on SOC stabilization (Diekow et al., 2005a; Álvaro-Fuentes et al.,
- 83 2009; Andruschkewitsch et al., 2013; Conceição et al., 2013). Despite the wide range of
- 84 fractionation schemes used (Cambardella and Elliot, 1992; Diekow et al., 2005a;

85 Conceição et al., 2008), three main fractions related to mechanisms of C stabilization

- are usually assessed. The free light fraction (free-LF) which is considered a non-
- 87 protected C-pool, the occluded light fraction (occluded-LF) that is fraction located
- inside of soil aggregates and assumed to be physically-protected against the attack of
- soil microrganisms and their enzymes, and the mineral-associated fraction (min-OM)

- that is a colloidal fraction interacting with mineral particles (Six et al., 1999; Rumpel et 90 al., 2010; Conceição et al., 2013). Carbon occlusion and organomineral association are 91 considered the main mechanisms of C stabilization in tropical and subtropical soils with 92 a predominance of Kaolinite (1:1 clay) and sequioxides of Al and Fe (Conceição et al., 93 2013; Denef et al., 2007; Zotarelli et al., 2007). 94 It has been suggested that SOC stabilization in NT soils is closely linked to soil 95 macroaggregation (Six et al., 1999; Conceição et al., 2013). The slower turnover of 96 97 macroaggregates would favor the formation and stabilization of microaggregates within macroaggregates (Six et al., 1999; Denef et al., 2004; Du et al., 2015), and provide an 98 environment for C to be chemically stabilized by soil minerals (Conceição et al., 2013). 99 However, the mechanisms by which different cropping systems affect SOC stabilization 100 is still unclear, especially in tropical and subtropical soils. 101 The hypothesis of this work was that soil management systems involving no soil 102 disturbance (NT) and associated with large and diversified crop residue input, increase 103 the C occlusion in macroaggregates and, consequently, favour the formation of 104 105 organomineral associations and ultimately SOC stabilization. Our objective was to test this hypothesis using a combination of aggregate size and organic matter density 106 fractionation, on a 30 year-old experiment of southern Brazil combining tillage and 107 108 cropping systems with legume cover crops. 109 110 2. Materials and methods
- 111 2.1 Field experiment
- 112 This study was based on a long-term field experiment (30 years) initiated in 1985 in an
- area previously cultivated for approximately 16 years under conventional tillage, with
- 114 plowing and disking, at the Experimental Station of the Federal University of Rio

Grande do Sul, Eldorado do Sul, Rio Grande do Sul State, Brazil. Soil and climate
characteristics are presented in Table 1.

The ongoing experiment consists of the combination of two tillage [conventional 117 tillage (CT) and no tillage (NT)] systems with three cropping systems [oats (Avena 118 strigosa Schreb) / maize (Zea mays L.) (O/M), vetch (Vicia sativa L.) / maize (V/M) 119 and the consortium of oats + vetch / maize + cowpea (Vigna ugniculata (L.) Walp) 120 (OV/MC)] distributed in a randomized block experimental design with split plots and 121 122 three replicates. Tillage systems were assigned to the main plots $(15 \times 20 \text{ m})$ and cropping systems to the subplots $(5 \times 20 \text{ m})$. These tillage systems combined with 123 cropping systems were managed at two levels of fertilization: 0 and 180 kg ha⁻¹ of N-124 urea (0N and 180N), applied manually in strips in the maize crop, characterized the sub-125 126 subplots (5 \times 10 m). Only the sub-subplots with no nitrogen fertilization were used in this study. 127 Winter crops, managed as cover crops, were established in April-May of each 128

year using direct drilling in both CT and NT treatments. Oats, when grown alone, were
seeded at a rate of 80 kg ha⁻¹. When cultivated with vetch, oats were seeded at 30 kg
ha⁻¹ and vetch at 50 kg ha⁻¹. For vetch cultivated on its own, 80 kg ha⁻¹ was used. In the
OV/MC system, cowpea (summer cover crop) was manually sown 15 to 20 days after
maize, between the lines of this crop, in pits 40 cm apart, with 3 to 4 seeds per pit. After
the maize was harvested, cowpea was allowed to grow to its full development,

remaining until its mechanical management by knife roller before the winter crops were
planted (oats and vetch).

The CT plots were ploughed to a furrow-depth of 17 cm once a year in spring
before maize sowing using a three-disk plough and harrowed twice to a depth of 10 cm
using a disk harrow mixing the crops residues in this layer. At the same time,

glyphosate-based herbicide (Roundup, Monsanto) was applied in the NT plots at 1.4 kg
ha⁻¹ with respect to final glyphosate concentration, and two or three days later the
winter cover crops were managed with a knife-roller and the aboveground residues left
on the soil surface. In NT, soil disturbance occurred only in the sowing line, and the
residues of the cover crop were left on the soil surface.

- 145 Maize was planted with a NT planter in both tillage treatments in September–
- 146 October, with 90 cm spacing between rows and using a sowing rate adjusted to obtain
- 147 50–70 thousand plants per hectare. The fertilizers were applied at 8 cm soil depth at
- maize sowing, at rates of 21.5 and 41.5 kg ha⁻¹ of P and K, respectively (50 kg ha⁻¹ of
- 149 P_2O_5 and K_2O each). The mean historic annual C input for both cover crops and maize
- are provided in Table 1. The mean annual C input (aboveground and root, with roots

being assumed to account for 30% of the aboveground portion) was calculated from

152 cover crop data and the dry-matter maize yields compiled by Zanatta et al. (2007) for

- the period 1985–2006, which were subsequently updated to 2014 (Fig. 1) (Veloso et al.,
- 154 **2018**).

155 2.2 Soil bulk density and total organic carbon determinations

156 Soil sampling was carried out in September 2014 in the 0–5, 5–10 and 10–20 cm soil

- 157 layers, prior to soil tillage for maize crop establishment. Trenches were opened,
- 158 perpendicular to the sowing lines, for sampling for bulk density which was measured in
- duplicate using the volumetric ring method (volume of 101.5 cm³) (Blake and Hartge,
- 160 1986). Soil samples were collected from the different layers for SOC analysis. The
- samples were air-dried, ground and passed through a 2-mm-mesh sieve, and then
- 162 ground in an agate mortar. The determination of SOC concentrations by dry combustion
- 163 was performed using an elemental analyzer (FlashEA 1112, Thermo, Electron
- 164 Corporation, Milan, Italy).

165	The SOC stocks up to a depth of 20 cm were calculated using the equivalent
166	mass approach (Ellert and Bettany, 1995), taking the soil mass of CT O/M management
167	system as the reference. The annual SOC accumulation rate was calculated as the
168	difference between the SOC stocks of the treatments and the reference system, divided
169	by the time elapsed since the implementation of the experiment, i.e. 30 years.
170	
171	2.3 Aggregate size distribution and physical fractionation of SOM
172	At the same period, additional trenches were excavated with a cutting blade in order to
173	sample undisturbed soil in the 0-5, 5-10 and 10-20 cm layers for aggregate
174	fractionation. These undisturbed samples were manually ruptured at their weakness
175	points until the entire sample could be passed through a 9.51-mm mesh and dried in the
176	shade. Aggregates larger and smaller than 2 mm were weighed to determine the
177	proportion of aggregates making up the soil mass required to analyze the aggregate size
178	distribution in water and the physical density fractionation of SOM.
179	To determine the size distribution of aggregates in water, 50 g samples of soil
180	were weighed and moistened by capillarity for 12 hours on filter paper. Separations
181	were run in duplicate. Afterwards, they were transferred to 1000 mL plastic tubes
182	containing 500 ml of water and placed on a rotary shaker for 2 min at 16 rpm. The
183	samples were then transferred to the vertical oscillation shaker, following the procedure
184	of Carpenedo and Mielniczuk (1990). The samples were placed on a set of sieves with
185	mesh sizes 4.76, 2.00, 0.50, 0.25, and 0.053 mm, and shaken in water at 42 oscillations
186	per minute for 15 min, so that water at the lowest level reached the top of the aggregates
187	in the 4.76 mm sieve. The material that passed through the last sieve and was retained in
188	the bucket was flocculated with potassium aluminum (5 g L^{-1}).

105	The contents of the five sleves the the soliton were transferred to pluste			
190	containers of known mass, dried for 48 h at 60 °C and then weighed. The mean weight			
191	diameter (MWD) was calculated from the aggregates retained in the five sieves and the			
192	bottom pan (equation 1):

194	Where: MWD = mean weight diameter (mm); mAGRi = mass of aggregates in			
195	class i; Ci = mean value of the class of aggregate class [(upper mesh diameter + lower			
196	mesh diameter) / 2]; mAGR = total mass of aggregates of the six classes. The soil			
197	aggregate classes were pooled in large macroagreggates (> 2 mm), small			
198	macroaggregates (2-0.250 mm) and microaggregates (<0.250 mm). The SOC			
199	concentration of these aggregate size fractions was determined as previously described.			
200	For the physical fractionation of SOM from large macroaggregates, small			
201	macroaggregates and microaggregates, 10-g samples from each soil aggregate class			
202	were placed in centrifuge tubes containing 80 ml of sodium polytungstate solution			
203	(SPT) (2.0 g cm^{-3}) (Figure 1). After closure of the stopper tube and slow and manual			
204	stirring, the free-LF of the OM was released (Conceição et al., 2008). The suspension			
205	was centrifuged at $\frac{2000 \ g}{1000 \ g}$ for 90 minutes. The supernatant, which contained the free-LF,			
206	was filtered under vacuum. To remove excess SPT, the free-LF was washed with			
207	distilled water and calcium chloride solution (CaCl ₂) (0.01 mol L^{-1}). The SPT solution			
208	(contained in the free-LF supernatant) was returned to the tube and the suspension was			
209	subjected to ultrasonic vibration dispersion at the 240 J mL ^{-1} level in order to disperse			
210	the soil aggregates. This level of energy was previously defined as sufficient to disperse			
211	organomineral complexes > 2 μ m in order to obtain 99% of the total clay fraction (Inda			
212	Junior et al., 2007).			

The contents of the five sieves and the bottom were transferred to plastic

After sample dispersion, the suspension was centrifuged again and the occluded-LF fraction was separated by following the same procedure as for free-LF. The free-LF and occluded-LF fractions were oven dried at 60 °C, ground in an agate mortar, and analyzed for C as previously described. The C-min-OM was obtained by calculating the difference between SOC and C of the C-free-LF + C-occluded-LF. The C recovery in each soil aggregate class ranged from 85 to 96% of the SOC.

220 2.4 Statistical analysis

Data were subjected to analysis of variance (ANOVA) and, when significant (p 221 <0.05), the differences between means of treatments were evaluated by the Tukey test at 222 the 5% level. To compare the effects of the tillage (T) and cropping (CC) systems on the 223 SOC variables, the MIXED procedure was performed, which considered the main 224 225 factors and their interactions as fixed factors, and the block and the experimental errors as random variables. 239 *3.1 Soil organic carbon*

240	The SOC concentration was higher in the superficial soil layer (0–5 cm) under NT




Figure 2. Soil organic carbon concentration in 0–5, 5–10 and 10–20 cm of sandy clay loam Acrisol subjected for long-term to conventional tillage (CT) and no-tillage (NT) (a) in combination with three cropping systems [oat/maize (O/M), vetch/maize (V/M) and oat+vetch/maize+cowpea (OV/MC)] (b).

241	compared to CT, but this difference disappeared in the underlying layers (Figure 2a).
242	The SOC stocks down to a depth of 20 cm depth were therefore similar for the two
243	tillage systems (Table 2). However, cropping systems had a strong effect on SOC
244	stocks, which varied from 33.1 to 40.8 Mg C ha ^{-1} , with a gradual increase due to
245	legume cover crop insertion in the cropping systems (Table 2). Consequently, on
246	average, legume-based cropping systems had the SOC accumulation rate 0.25 Mg C
247	$ha^{-1} yr^{-1}$ higher than traditional cropping system involving non legume crops (O/M)
248	(Table 2).
249	
250	3.2 Soil aggregation
251	The proportion of soil aggregates was strongly affected by tillage systems down




Figure 3. Soil aggregate size-class distribution and mean weight diameter (MWD) in the (a) 0–5,

252	to a depth of 20 cm (Figure 3 a, b, c). In the three soil layers, NT (average of 34.6%)
253	resulted in a greater proportion of large macroaggregates compared to CT (average of
254	20.1%), yielding a MWD of 1.3 mm for CT and 2.2 mm for NT. The cropping systems

influenced the proportion of soil aggregates only in the 0-5 cm depth. In this soil layer,

the proportion of large macroaggregates was 40% greater and the MWD 24% greater,





Figure 4. Aggregate size-class distribution and mean weight diameter (MWD) in the (a) 0–5, (b)

- 257 under OV/MC compared to O/M (Figure 4 a).

259 *3.3 SOC concentration in soil aggregates*

Tillage and cropping systems differed in their effects on SOC concentrations in the three aggregate size classes, and these effects were mostly visible in the 0–5 cm soil layer (Figure 4). The SOC concentration in both macroaggregate fractions ranged from

263	10.3 to 19.5 g kg ^{-1} , and was affected mainly by tillage systems (Figure 5 a, b). The SOC		
264	concentration in the large and small macroaggregates in the superficial soil layer was		
265	5.1 and 4.0 g C kg ^{-1} higher under NT than under CT, respectively (Figure 5 a, b). On		
266	the other hand, cropping systems had a greater effect on the small macroaggregates		
267	(Figure 5 e) and an especially noticeable effect on the microaggregates in the superficial		
268	soil layer (Figure 4 f), with SOC concentrations in microaggregates varying between		
269	15.3 and 21.3 g kg ^{-1} . More noticeably, the system with two legume cover crops		
270	(OV/MC) showed a strong C enrichment in the microaggregates of the superficial soil		
271	layer compared to system with no legume cover crop (O/M) (Figure 5 f).

management systems, accounting from 9 to 27% of SOC, and was strongly influenced

by soil tillage systems. The occluded-LF-C concentration was 2.2-, 2.8- and 2.6-fold

284 larger, in the large and small macroaggregates and the soil microaggregates,

285 respectively, under NT system compared to CT (Table 3). The highest C concentration

was found in the large macroaggregates under NT (4.9 g kg⁻¹) (Table 3). The occluded-

287 LF-C concentration was 70, 69 and 84% greater in large and small macroaggregates and

288 microaggregates, respectively, under OV/MC compared to O/M cropping system (Table
289 3).

290	The min-OM fraction accounted for the majority of the C contained in all				
291	aggregate fractions (Table 3). The cropping systems had a strong effect on min-OM of				
292	microaggregates, especially under NT (Table 3) where it was 64% greater under				
293	OV/MC compared to O/M (Table 3). Although the effect was less pronounced, the main				
294	effect of tillage system was also significant in large macroagregates, where the min-				
295	OM-C concentration was 28% greater in NT compared to CT (Table 3).				
296	In all three aggregate fractions, in the $0-5$ cm layer only, there was a significant				
297	positive correlation between the concentration of occluded-LF-C and min-OM-C (Fig.				
298	<mark>6).</mark>

343	with legume cover crops.

345	5. Conclusions
346	The mechanisms by which no-tillage and legume cover crops favor soil C
347	accumulation in a subtropical Acrisol differ. No-tillage has a positive impact on C








Figure 6. Regression of C concentration in the mineral associated organic matter (Min- MO-C)
